- 2. Copy of valid CNIC/ Passport (in case of foreigner) should be enclosed with the Postal Ballot paper form.
- 3. Ballot Paper should reach the Chairman within business hours by or before **July 11, 2024.** Any Postal Ballot received after this date, will not be considered for voting.
- 4. Signature on Ballot Paper should match with signature on valid CNIC/ Passport. (In case of foreigner).
- 5. Incomplete, unsigned, incorrect, defaced, torn, mutilated, over written poll paper will be rejected.
- 6. In case of a representative of a body corporate, corporation or Federal Government, the Postal Ballot paper form must be accompanied by a copy of the valid CNIC of an authorized person, an attested copy of Board Resolution, / Power of Attorney / Authorization Letter etc., in accordance with Section(s) 138 or 139 of the Companies Act, 2017 as applicable.
